

ACCEPTANCE

I have read, understood, and fully accepted the Chase Sports Playgrounds terms and conditions in their entirety and without limitation. I give my consent and grant permission for the Player to participate in Chase Sports Playgrounds activities and any events organized by the Academy.

I confirm that the Player is physically fit to take part in sporting activities.

I understand that participation in these activities is entirely at our own risk. Therefore, I agree not to hold Chase Sports Playgrounds, its employees, or representatives responsible or liable for any damage or loss of property.

In the event of an injury sustained during training, Chase Sports Playgrounds will take immediate action to treat the Player; however, it will not be responsible or liable for any aftercare or further treatment required.

I authorize Chase Sports Playgrounds for marketing and advertising purposes to take, record, post, and share images/videos or photographs of the Player while participating in activities, without entitlement to any compensation or remuneration.

GENERAL

- Training sessions are closed and reserved for Players and their parents/guardians.
- Chase Sports Playgrounds is not responsible for any photos or videos taken by individuals other than its authorized staff, nor for how such materials are shared or used.
- For the safety of all participants, please do not bring the Player to sessions if they have symptoms of cold, flu, fever, cough, high temperature, breathing difficulties, respiratory disease, or immunodeficiency.

PAYMENT POLICY

- Payment is due on the first day of the monthly sessions.
- Payment should be made no later than one week after the due date, unless a valid reason is provided and an exception is approved.
- A late fee of AED 25 will be added to the bill for each week the payment remains overdue.

- If payment is more than one month late, the child/children will not be permitted to participate in classes until all outstanding fees for both the previous and upcoming month are paid in full.

CANCELLATION & REFUNDS

- Session fees are non-refundable in the case of Player absence, and missed days cannot be carried over to the following month.
- Refunds for the balance of remaining sessions will only be given in the following cases:
 - Severe medical reasons preventing participation (medical report required).
 - Relocation to another Emirate or country.
 - Session cancellation by Chase Sports Playgrounds for any reason (in which case the balance will be refunded in cash or carried forward to the next term).
 - Sessions canceled due to public holidays will not be carried over.

LIABILITY

- Parents and Players must always act respectfully while on the premises and when interacting with staff, other parents, and students.
- Chase Sports Playgrounds reserves the right to refuse entry or remove any Player displaying improper or abusive behavior.
- The Academy is not liable for any event beyond its control (force majeure) or for cancellations required by legal or regulatory directives.
